

## **TRAFFIC ORDER PROPOSALS : SCHOOL LANE / FARNHAM ROAD, SHEET – PROHIBITION OF LEFT AND RIGHT TURNS**

NOTICE IS HEREBY GIVEN that Hampshire County Council (“the Council”) proposes to make a traffic order, in exercise of its powers and duties under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and having discharged its duty under section 122 of the Act.

**THE GENERAL NATURE AND EFFECT OF THE ORDER:** Will be to prohibit vehicles from making left and right turn manoeuvres at the junction of School Lane and Farnham Road as follows:

- (i) No left turn from School Lane into Farnham Road: and
- (ii) No right turn from Farnham Road into School Lane
